**FIRE DEPT:** FD working on fund raisers; Trustees diVincenzo and Levison had one meeting with FD members about ladder truck possibilities...another one coming up.

**ZONING:** Working on a few items to be added to the code. Tina reports that there is someone (Cheryl Morrill) occupying the burned house at 3 Bernard Ave. There is no power or water to the property, the wood stove is being used, and it was posted as uninhabitable; a certificate of occupancy is needed before it can be occupied again to make sure any necessary repairs have been made.
