Now, Therefore, Be It Resolved that to fullest extent permitted by law, the Village of Norwood will indemnify and hold harmless the County, their officers, directors, partners, representatives, agents and employees from and against any and all claims, suits, liens, judgments damages, losses and expenses, including legal fees and all court costs and liability (including statutory liability) arising in whole or in part and in any manner from injury and/or death of person or damage to or loss of any property relating to or arising out of any negligent or intentional acts and/or omissions of the Village of Norwood or any of its directors, officers, employees, contractors, representatives, or agents.

Be It Further Resolved, that the following request for General Liability (GL) coverage is as follows: General Liability Insurance

On an "Occurrence" basis, with the following limits:

\$1,000,000 Each Occurrence

\$3,000,000 General Aggregate

\$1,000,000 Products Aggregate

\$1,000,000 Personal Injury

- \$ 50,000 Fire Damage Legal Liability
- \$ 5,000 Medical Payment Expense

Be It Further Resolved, that St. Lawrence County shall be an additional insured on the GL Policy, via ISO endorsement CG 2026.
