Treasurer: Balance Sheets are through December. TTE Nezezon asked if we could move some of the G Fund to a money market to earn interest.

DPW: Dan was absent but he provided his report. TTE diVencenzo questioned the Kubota bill, there was no description for the parts on the bill.

Water/Sewer: Update given by Mike Smith chlorine meter is out dated it is time to replace 3 other meters as well. We only have 2 back up meters. The truck for the plant needs to be replaced there is not really a way to rebuild the transmission. It is hard to find a truck with low millage. On the 25th there will be someone out to look at the pumps and let mike know if they can be rebuilt. S. Main St transfer switch for the generator will not automatically turn on.nm5

Police: Report presented. The department dayshift is working out very well. They have been monitoring the busses as well as the cross walks. TTE diVencenzo asked if there was any thoughts on how to fix the problem with the bus drop off at Head Start. This has been a tough situation. OIC Wells received a letter from a Deputy Sheriff from a different county, she is running in a marathon on April 20th to benefit Cops for Kids with Cancer. This is not something that the Village can donate to but we could all individually donate money. The Mayor will take on to the Lake Association as well. There has been an arrest for the fire at 14S Main St. The charge was for criminal mischief

Fire Department: 12 calls this month. They have no bills to pay this month but will be looking at replacing the air packs next month. There have been to members who have left Eric Parham and Nate Hagett. Nancy will get the department the flash drive for the Sexual Harassment so the department will be covered.

Zoning: Bill presented his monthly report. Kuenzler would like to sell a portion of their property and give access to the property through their access road. Bill has been in contact with Sally Sutter the owner of 14S. Main, the Mayor stated that when the work starts that they should start pulling down the building from the back.
