## 5. CODE ENFORCEMENT REPORT

Written report provided. Code Enforcement Officer, Jeff Murray, noted he plans to consult the Historian on materials he has found while organizing Code documents in the Boardroom.

## 6. MUNICIPAL WATER/WASTE WATER TREATMENT PLANT REPORT

Written report provided. Mayor Tebo noted that the 90-degree flange needed for the wet well is on order and will be installed to complete the pump installation. This will fulfill the requirements needed to pass inspection.

## 7. POLICE DEPARTMENT REPORT

Written report provided. Trustee Levison reported that she was notified that Sue Fregoe did not get a response from the PD when she called on December 7<sup>th</sup> for involvement in the Holiday parade. Police Chief Wells reported that he was not asked prior to the event therefore did not feel responsibility to attend/participate. Trustee Fetter noted that an invitation should not be required as the parade coverage was scheduled on the PD calendar. Trustee Tebo noted that an effort for improved communication for all parties should be made.

### 8. FIRE DEPARTMENT

Nate Durand reported that the Fire Department received one new application. Also noted, the FD will be proposing a complete plan at the January 2025 Board Meeting to conduct a training with neighboring Fire Departments at the old school on Prospect Street.

## 9. MAYORS COMMENTS

Mayor Tebo reported Atlantic Testing Laboratories will begin performing drilling/field work for the WWTP starting on 12/23/24. An NCC quote for the installation of an additional camera on the Municipal Hall was received; this will not be pursued at this time due to high cost. Mayor Tebo requested the Board vote on street lights and sewer pipeline.

A motion was made by Trustee Tebo and Seconded by Trustee Fetter to seek bids for the completion of the street lights.

The supplemental schedule for updates to the General Code requires a Board decision. Quotes will be pursued for each update option; yearly, quarterly and as needed. The bill for IT services/equipment was presented to the Board as well as a proposal for service/billing options moving forward.

A motion was made by Trustee Levison and Seconded by Trustee Tebo to approve services provided by New Horizons Tech Consulting: "Option #2: \$3330; 90 hours' worth of support with overage billed at \$40."

Potsdam Town Supervisor, Marty Miller, reported to Mayor Tebo updates on the dry bridge. Meetings have been held with engineers/planners/architects/CSX; drilling test holes for soil samples will take place 100 feet around the bridge. There are plans for a new bridge that will facilitate travel for all vehicles. Miller noted that funding for the project is unlikely due to it being low on the State's priority list; the Town of Potsdam will look into bonding to fund the project.
